Today i.e., 07/09/2024 at 7.30 am received an information that on the same day at about 7.25 am, an exchange of heavy firing happened in between suspected armed village volunteers of Jiribam and suspected armed Kuki militants at the Tea Estate of Rashidpur Part-II, Jiribam. On receipt of the information self with teams of CDO/Unit, Jiribam led by OC/CDO, Jiribam and teams of JBM-PS, under the supervision of SP/Jiribam immediately rushed towards the Tea Estate of Rashidpur Part-II village, Jiribam. Before reaching the site of firing incident some unknown persons had fired some rounds towards the police teams. The police team also retaliated the fire and the unknown miscreants fled away towards unknown directions under the cover of thick bushes. The police teams took position there and at around 10.30 am the firing was stopped. In the meantime, Addl. SP (L/O), Jiribam, teams of 39 AR led by CO 39 Assam Rifles, Kadamtala, Jiribam and teams of CRPF led by DIG (Tcc/Hqr), Jiribam were also arrived there. Later on, the unified team proceeded further towards the firing incident site at Tea Estate of Rashidpur Part-II, Jiribam and conducted a thorough searched of the area. In that, 5 (five) unknown male bodies who had already died at the spot were found at different locations. During the searched first one dead body who later identified as Baspatimayun Lakhi Kumar Sharma @ Bungana @ Henthoi (41) yrs s/o, B. Shyamson of Dibong Khunou, Jiribam alleged to be a village volunteer was found and then another 4 (four) unknown dead bodies suspected to be Kuki militants along with one MA-1 rifle were found from a place which was about 300 meters away from the first recovery. The following items were found on conducting through searched of the area from where the later 4 (four) dead bodies were found, (1) 1 (one) no. MA-1 of rifle (2) 2 (two) nos. of MA-1 magazine (3) 24 (twenty four) nos. of 7.62 (SLR) empty cases (4) 8 (eight) nos. of 7.62 (AK) empty cases (5) 7 (seven) nos. of 5.56 (INSAS) empty cases (6) 1 (one) no. of 30-06 empty case (7) 1 (one) no. of .303 empty case (8) 5 (five) nos. of 5.56 live round (9) 1(one) no. of 12 bore ammunition (empty case) (10) 1 (one) no. of INSAS magazine (broken) (11) 1 (one) raincoat (12) 1 (one) T-Shirt (Camouflage) (13) 3 (three) nos. of Magazine post.

The dead bodies were kept at Temporary Mortuary of 50 bedded Hospital, Jiribam and the recovered items were brought at Police Station for further legal formalities.

Hence a Suo-Motto case under **FIR No. 68 (09) 2024 JBM-PS u/s 109/103(2)/310(6)/3(5) BNS & 25 (1-A) A. Act.** has been registered for investigation.
