I have the honour to report that on 14/09/2024 at around 7.30 pm, there was an incident of firing between Mongbung Meitei village and Mongbung Kuki village of Jiribam. However, no report of casualty during the incident. As a follow up action of the incident, today i.e., 15/09/2024 at around 9.30 am, a joint search operation was conducted comprising of District Police, Jiribam led by Superintendent of Police, Jiribam, Addl. SP (L/O), Jiribam, Teams of CDO/Unit, Jiribam, troops of CRPF led by DIG (Tec/HQr) including CO-87 Bn. CRPF, CO-156 BN. CRPF & 2ic- Dett. 20 Bn. CRPF and troops of 39 Assam Rifles led by CO-39 AR, Kadamtala, Jiribam in the general area of Mongbung village, Jiribam. The joint searched operation was ended on the same day at 1.50 pm.
