I have the honour to report that on 29/09/2024 at around 8.40 pm, there was an incident of firing between unknown miscreants of Mongbung Meitei village and Mongbung Kuki village of Jiribam District. However, there was no report of casualty during the incident. As a follow up action of the incident, today i.e., 30/09/2024 at around 8.00 am, a joint search operation was conducted comprising of District Police, Jiribam led by Superintendent of Police, Jiribam, Addl. SP (L/O), Jiribam, teams of Jiribam Police Station, teams of CDO/Unit, Jiribam led by OC/CDO Unit-JBM, CO-7<sup>th</sup> IRB, troops of CRPF led by DIG (Tec/HQr) including CO-87 Bn. CRPF, CO-Dett.156 Bn. CRPF, 2 I/C Dett. 20 Bn. CRPF & troops of 39 Assam Rifles, Kadamtala, Jiribam under the overall supervision of Shri, Kamei Angam Romanus, IPS, IGP (Z-III) Manipur in the general areas of Mongbung Meitei village, Mongbung Kuki village, Kashimpur Balijuri village and surrounding areas. The joint searched operation was ended on the same day at about 1.30 pm.




