MN06SA-8079 got bullet injury and undergoing medical treatment at Shija Hospital, Langol.

On visiting the spot it came to light that my son was shot by some unknown persons coming on a Bolero, Black in colour, registration number not known along the Lamphel Sanakeithel road in front of Zero Point restaurant at about 2.30 pm.
