Sir,

I have the honour to state that today i.e. 12/07/2024 at about 11:30 am on receipt of reliable information from 22 AR and further corroborated from our own sources about the presence of some unknown armed persons in and around Changangei Ucheckon area with a view to commit prejudicial unknown arms of money from the general public, shops etc. Acting on the information,

teams of CDO-IW led by Shri P. Achouba Meetei, MPS, OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted frisking and checking and round patrolling at Changangei Ucheckon, Tiddim Road. While our CDO-IW team were conducting round patrolling at Changangei Ucheckon, Tiddim Road, one unknown person was entering a tea hotel in a very suspicious manner and our team immediately rushed to the said tea hotel namely Sinngambi Fast Food run by one Laishram Mimi Devi (50 yrs) W/o. L. Milam of Changangei Ucheckon and successfully detained him for spot verification and checking. Spot verification and checking of the detained person was done with the recording of audio-videography. During spot verification he identified himself as Takhellembam Inao Singh (39 yrs) @ Ningthiba S/o. (L) T. Babu Singh of Serou Mayai Leikai, Kakching District a/p Relief Camp Lamboikhongnangkhong, Imphal West. He further disclosed that he is an active cadre of RPF/PLA organisation and he joined the said organisation in the year 2001 and got basic military training at Sajik Tampak in the year 2001 and was allotted army no. 2466 of 2001 batched and presently working under the command of one Manglemiao who is working as s/s Finance Secretary of Imphal West District of RPF/PLA organisation and he frequently communicated his commander through the mobile number 6909225190. He further disclosed that he kept a Pistol on a cartoon box in the said tea hotel. Immediately, our team started searching and as pointed out by the detainee our team recovered one 9mm Pistol bearing number 18257486 along with one magazine loaded with 7 (seven) rounds of 9mm ammunition on a cartoon box at the said tea hotel at his instance. On further checking, one black wallet containing a sum of Rs. 1700/- (Rupees one thousand seven hundred only) and two mobile handsets i.e., (i) one Vivo mobile handset along with two SIM cards i.e., (a) one Airtel SIM card bearing mobile number 8731959535 (as disclosed by him) and (b) one Jio SIM card bearing mobile number (not known) and (ii) one MI mobile handset along with two Airtel SIM cards (mobile numbers not known) were recovered from his possession.

On asking about the above recovered 9mm Pistol, he disclosed that the said 9mm Pistol was delivered to him by one unknown person on 11/07/2024 at Lamboikhongnangkhong as instructed by his commander Manglemjao. He further disclosed that under the instruction of his commander he recently made monetary demands to various educational institutes and general public etc in and around lmphal area. Hence, he was arrested at the spot at 12:10 pm and the above recovered articles were seized at 12:13 pm in presence of an independent witness by observing formalities.

Hence, the arrested person along with the seized articles is handed over to you for taking further necessary legal action against him.
