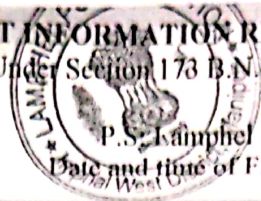

Subject: - Report.

Sir,

I have the honour to state that yesterday i.e. 26/07/2024 at about 09:25 pm, an information was received from Mike-64 (Commando Control) about an incident of gun firing and mob violence at Dingku Road near ISBT complex. Acting on the information, teams of CDO-IW led by Shri P. Achouba Meetei, MPS, OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.)IW and



under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted round patrolling and checking in and around the said area. During that our team detained four unknown persons who were found in a suspicious manner in a Maruti Gypsy dark green in colour bearing Registration No. MN07D 3493 in front of Vishal Mart, Chingmeirong for spot verification and checking. During spot verification and checking, they identified themselves as:

1) Thounaojam Gopen Singh @ Shakti (34 yrs) s/o Th. Kebol Singh of Salam Mayai Leikai, Imphal West District. From his possession, the following articles were recovered: (i) one side bag black in colour containing with (a) one pistol with one ammunition in its chamber, (b) one broken magazine, (c) one 7.65 mm ammunition and (d) one wallet cream in colour and (ii) one One Plus one go 5G mobile handset along with one Airtel SIM card bearing mobile number 8787824890 (as disclosed by him).

2) Naorem Ningthouremba Meitei (25 yrs) @ Ningthou s/o N. Dolen Meitei of Heibongpokpi Mayai Leikai, Imphal West District. From his possession, one Redmi 9 mobile handset along with one Jio SIM card bearing mobile number 9863485285 (as disclosed by him) was recovered.

3) Arambam Tom Meitei (35 yrs) @ Thawailakpa s/o A. Jhalajit Meitei of Heibongpokpi Mayai Leikai, Imphal West District (Driver of the Maruti Gypsy). From his possession, one Maruti Gypsy dark green in colour bearing Registration No. MN07D 3493 was recovered.

4) Laishram Joshikumar Singh (28 yrs) @ Awpa s/o L. Sanjoy Singh of Khamran Mamang Leikai, Khonghampat, Imphal West District. From his possession, the following articles were recovered: (i) one iPhone 12 mobile handset along with one Airtel SIM card bearing mobile number 6909509219 (as disclosed by him), (ii) one Redmi 7 Pro mobile handset along with one Airtel SIM card bearing mobile number 8787889694 and (iii) one side bag black in colour containing one black wallet with a sum of Rs. 1470/- (rupees one thousand four hundred and seventy only).

During spot checking they were found to be heavily drunk and two of them namely Thounaojam Gopen Singh and Arambam Tom Meitei got severe injury on their persons. On spot verification, they also disclosed that they got injury on their persons resulted from a quarrelling with a crowd near the Ocean Lounge located at Dingku Road opposite to ISBT complex. Due to their severe injury, immediately, our team evacuated them to RIMS Hospital, Lamphel for medical treatment as instructed by senior officers and hence, further verification and formal arrest/seizure procedure could not be done at the spot.

During medical examination at RIMS Hospital, they were found under alcoholic influence. After medical examination and treatment, they were brought to Lamphel Police Station At around 01:20 am of 27/07/2024 for further verification. Due to their inebriated condition, further verification could not be done properly. Hence, further verification was started at around 04:00 am. During further verification, Arambam Tom Meitei disclosed that he fired some rounds from the above recovered pistol (which was recovered from the possession of Thounaojam Gopen Singh earlier) during the quarrelling with the above-mentioned crowd near the Ocean Lounge located at Dingku Road opposite to ISBT. Further, they disclosed that they are active members of UNLF organisation.

Hence, they were arrested at Lamphel Police Station at 05:00 am, 05:10 am, 05:20 am and 05:30 am and the above recovered articles were seized at 05:05 am, 05:15 am, 05:25 am, 05:35 am respectively by observing formalities.

Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
