Sub: Request for taking appropriate legal action against those who were involved in burning down my valuable properties mentioned hereinbelow and punish them according to the law of the country.

Sir.

With due respect, I beg to state that I was informed by my men that some persons forcibly entered into the campus of my land at Ghari Awang Leikai about 02:00 am to-day i.e. 31/07/2024 and burnt down my valuable properties viz. (1) A tin roof house having 200ft.; (2) 1 (one) Verna Car, bearing Regd. No. MNO1G/1153; (3) 1 (one) Maruti Car, bearing Regd. No. MN01G/0759; (4) 1 (one) TATA Nano Car, bearing Regd. No. MN05A/2892, (5) 1 (one) School Bus, bearing Regd. No. MN05C/1923; (6) Around 80 pots of Paddy; (7) Diesel Drums (Barel); (8) Desk + Bench 300 numbers; (9) 5 (five) Almirah, (10) 2 (two) numbers of Vibrater machine; (11) 2 (two) numbers of Water pump; (12) 12 (twelve) numbers of Readymade doors; (13) 25 (twenty five) numbers of windows; (14) 15 (fifteen) numbers of Ventilators; (15) 30 (thirty) pices of Ply Wood (8x4); (16) 25 (twenty five) numbers of Ngari Chaphu; (17) 12 (twelve) number of Washing Machine; (18) 12 numbers of Indian Water Closet; (19) Anglo Water closet WC; (20) 12 numbers of Floor mounted uro peon toilet; (21) 2 (two) numbers of Gas Stove with 4 (four) numbers of Gas Cylinder; (22) 6 (six) number of Pressure Cooker; (23) 1 (one) number of Oven (24) 1 (one) numbers of Mixer and Grinder; (25) 6 (six) bundles of Binding wire; (26) 65 pieces of Steel Compak; (27) 35 (thirty five) numbers of Steel Bucket; and (28) 12 (twelve) numbers of Spade, etc.

The said incident is co-related with the unwanted incident happened to me on 29/06/2024. In the said incident happened on 29/06/2024 I and my husband namely Gurumayum Jayenta Sharma were kidnapped and confined by Kaguihemliu, W/o Ng. Pamei Kabui of Parengba Village Nungsai Chiru, P.O. & P.S. Bishnupur, Senapati District, Manipur and her said husband along with their hired men wrongfully in a house located somewhere at Imphal area and they freed me and my husband at about 11:30 p.m. of that night. They threatened me to pay the sum of Rs.25,00,000/- (Rupees twenty-five lakhs) only to the said Kaguihemliu and her husband namely, Ng. Pamei Kabui and out of the said Rs.25,00,000/- 1 should pay the sum of Rs.5,00,000/- to them on the next following day i.e. 30/06/2024 before 09:00 a.m. otherwise I would faced dire consequences.

After that day, the hired unknown men of Kaguihemliu and her husband namely Pamei Kabui have been looking for me round the clock till date even at my parental house as well as the houses of my relatives. In connection with the said unwanted incident happened on 29/06/2024, l lodged a written report dated 26/07/2024 to the Officer-in-Charge, Bishnupur Police Station for taking appropriate legal action against the said Smt. Kaguihemliu and her husband namely Ng. Pamei Kabui along with their men. The copy of the said written report dated 26/07/2024 was also endorsed to the Director General of Police, Manipur & Superintendent of Police, Bishnupur for information.

I, therefore, request your kind self for taking appropriate action against Smt. Kaguihemliu and her husband namely Ng. Pamei Kabui along with their hired men for burning down my valuable properties and punish them according to law. I also further request your kind self to record my statement if needed to a safety place as my life is risky now.
