Sir.

I have the honour to state that on 14/06/2024 at @ 6:00 pm one person namely Jamuna Devi 60yrs d/o (L) N. Mohori Singh of Langol Ningthou Leikai, Imphal West, Manipur lodged a written report to OC/LPS stating that his brother was expired on 14/06/2024 at about 10:00 am at I.C.U.RIMS Hospital, Lamphelpat, Imphal West District, Manipur and that she have filed an application for missing of him to Lamphel PS on 10/06/2024. That, he was engaged by two persons namely, 1. Sanjenbam Nilachandra Singh aged about 50-yrs s/o S. Lamphel of Langol, Imphal West Manipur. 2. Apam of Langol (60) s/o (L) H. Shangan of Ukhrul Mayotang, A/P-Lanthung Ching, Imphal-West District, Manipur and 3. Basanta of Langol, Imphal West District, Manipur to make fencing at Iroishemba they went by vehicle Carrier, Tata ACE driven by Basanta of Langol, Imphal West District, Manipur on 10/06/2024. However, he did not come at his home but the said three persons including the driver came back to their homes. Thereafter, she asked them where about of her said brother. However, they said he went to his home but on that day his where about was not known, on the next day, Anand brother of Basanta informed her that he was lying at Iroishemba and they found him at Iroishemba, he was unconscious when they found him then she brought him at RIMS Hospital, Lamphelpat, Imphal West on 11/06/2024 at about 1:00 pm and he was expired 14/06/2024 at about 10:00am at I.C.U RIMS

That, kindly take stringent legal action against the said persons who went with him and involved persons as his death is very doubtful.

That, she would like to receive a POSTMORTEM report regarding the death of her said younger brother to carry smooth investigation regarding death of her brother. Accordingly, the above UD case has been registered for enquiry. During the course of enquiry, examined the complainant and she corroborated with the O.E of the U.D. Case. Inquest has been conducted over the dead body of Nongmaithem Ibomcha and after the inquest the dead body was deposited to RIMS Mortuary for further formalities.

That, In further course of enquiry Magisterial inquest has been conducted over the dead body of late N. Ibomcha and further post mortem has been conducted over the dead body at RIMS Mortuary in presence of Executive Magistrate and under video coverage vide order of the Addl. District Magistrate. Imphal-West No. DM (IW)/1/398/I&PME/COM/04(Pt) dated 15th june,2024.

That in further course of enquiry, examined Sansenbam Nilachandra Singh (50) s/o (L) S. Lamphel Singh of Moidangpok Ibouthou Khoruhanba Leikai A/P-Langol Ningthou Leikai and Haorei Mayobam Apam (60) s/o (L) H. Shangan of Ukhrul Mayotang A/P Lanthungching Langol .On examination, they stated that on 10/06/2024, Nilachandra, Apam, Ibomcha went to the house of Ibomcha at Langol Ningthou Leikai in the carrier Tata Ace vehicle of Basanta to pick some bamboo. After loading the bamboo on the vehicle and proceeded to Chaoba's house at Iroisemba. On reaching Chaoba's house, Basanta dropped Nilachandra, Apam and Ibomcha and left the place for his work. They were cutting trees and trimming the grass as instructed by Chaoba. Later at about 11:00 am, Ibomcha asked for cigarette however, they replied that they did not have the eigarette. And Ibomcha went towards the road to buy eigarette. At about 1:00 pm, Chaoba prepared lunch for them. Till that time, Ibomcha was not returning, Nilachandra and Apam went to the road and search for Ibomcha. However, they did not find Ibomcha and returned to Chaoba's house to have the lunch with the thought that Ibomcha might be going home or drunk somewhere which he usually did. After having lunch, Nilachandra and Apam were paid Rs.200/ each by Chaoba. In the meantime, Basanta came to the Chaoba's house on his vehicle and they left Chaoba's house and went to the house of Ibomcha to enquire whether he returned home or not. Ibomcha was not returning home so, Apam and Basanta went to Iroisemba side and langol in search of Ibomcha. However, they could not trace Ibomcha. On the next day, they heard that Ibomcha was found lying at Iroisemba.

That in further course of enquiry, Post mortem report of Late N.
