Subject: - Report.

Sir,

I have the honour to state that today i.e. 07/08/2024 at about 03:30 pm. on receipt of reliable information from 33 AR and further corroborated from our own sources about the presence of some unknown armed persons in and around Changangei Awang Leikai area with a view to commit prejudicial activities like extortion of money from the general public, shops etc. Acting on the information, teams of CDO-IW led by Shri P. Achouba Meetei, MPS, OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS, Addl. SP(Ops.)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Changangei Awang Leikai. During that two persons were seen in a very suspicious manner in front of HOTEL ENCANTO located at Changangei Awang Leikai. Due to their suspicious manner, they were detained at the spot for verification and checking. During spot verification and checking, they identified themselves as: 1) Nongmeikapam Naoton Meitei @ Shanker @ Jiten @ Seidangba (45 yrs.) S/o. (L) N. Bidhu Singh of Koirou Thongju Part II. From his possession, one Redmi 13C mobile handset along with one Airtel SIM card bearing phone number 7085801590 (as disclosed by him) was recovered. 2) Moirangthem Premananda Singh @ Loyangamba @ Inaocha (50 yrs) S/o. (L) M. Ibomcha Singh of Moirang Kumam Leikai. From his possession, the following articles were recovered: (a) one Realme C55 mobile handset along with one Airtel SIM card bearing phone number 9233986845 (as disclosed by him). (b) one wallet containing one voter ID, one Pan Card and Rs. 200/- (Rupees two hundred only). During preliminary verification, Nongmeikapam Naoton Meitei disclosed that he is an active cadre of RPF/PLA organization and joined the said organization in the year 1999 and got basic military training at Daikhotang Jungle, Cepur in the year 1999 and was allotted Army no. 1800 and presently holding the rank of s/s Major of the said organization. Again, Moirangthem Premananda Singh disclosed that he is an active cadre of RPF/PLA organization and joined the said organization in the year 1993 and got basic military training in Bangladesh in the year 1994 and was allotted Army no. 0643 and presently holding the rank of s/s Major of the said organization. Further, they disclosed that they are presently working under the command of one s/s Major Suresh (Deputy Division) of RPF/PLA organization and under his instruction they were involved in extortion activities in and around Imphal area. Hence, they were arrested from the spot at 04:30 pm and 04:36 pm and the above recovered articles were seized at 04:33 pm and 04:39 pm respectively by observing formalities. Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
