With due respect and honour, I am to inform you that many furniture, racks, old computer monitors, office files/records, all of which are very old and in dilapidated condition, of Income Tax Office, Range-Imphal were kept under locked in a block of 4 (four) Quarters which were used as Store Room at Central Revenue Complex, Lamphelpat, Imphal as the quarters are laying vacant after May 31 (2023) incident in Manipur. The last time where we have shifted some more files was during the month of June/July 2024 (exact date is not remembered). Till that time everything was all right. But unfortunately, on 7th August 2024 (Wednesday), when some of our official staff went there to search for a particular file, it was found that the door was broken and opened. All items of furniture, iron racks, computer monitors, though in a dilapidated condition were found to be missing. All the office files/records were also found to be haphazardly lying on the ground with excessive wear and tear and found to be in a very difficult position to ascertain the whereabouts of particular files and if any of them were missing. The incident might have been done by some unknown persons.
