Mahindra Armada vehicle (White in color) bearing registration No. MN1-1222 has been stolen from the premises of the Communication and Capacity Development Unit (CCDU), Public Health Engineering Department (PHED), Manipur by unknown person. The incident occurred on the night of 23 July 2024, while the vehicle was parked at the PHED Lamphel

This vehicle, officially assigned to the Director of CCDU, PHED Manipur, has been office premises. non-operational for over ten years and is not in driving condition. It has remained parked on the premises for several years due to the prohibitive cost of repairs, which is not justified given the vehicle's age. The current estimated value of the vehicle is approximately Rs. 30,000/- (Thirty Thousand Only).

Unfortunately, the original documents related to the vehicle have been misplaced from the Department's custody, causing a delay in reporting the incident. The chassis number is not known, and a letter has been sent to the District Transport Officer (DTO), Imphal West, requesting the details. These details will be shared with your office as soon as we receive them from the DTO.

In light of this incident, the Department request your esteemed office to initiate an investigation into the matter. We believe that your prompt action and thorough investigation will be instrumental in recovering the missing vehicle and taking appropriate legal actions as per the law.
