Subject: - Report.

I have the bonour to state that today i.e. 25/08/2024 at about 12:30 pm, a reliable information was received from our own sources about the presence of some active cadres of KYKL organisation in and around Changangei Uchekon area with a view to commit prejudicial activities like extortion of money from the general public, shops etc. Acting on the information, teams of CDO-IW led by Shri P. Achouba Meetei, MPS, OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Changangei Uchekon area. During that three persons were found in a very suspicious manner near the gate of New-Tech Nursing Home located at Changangei Uchekon. Due to their suspicious nature they were detained at the spot for verification and checking. During spot verification and checking, they identified themselves as:

(i) Oinam Milan Singh (52 yrs) S/o. (L) O. Kokngang Singh of Wangkhei Hijam Leirak, Imphal East District. From his possession, (a) one wallet black in colour containing a sum of Rs. 2105/- (Rupees two thousand one hundred and five only), one Aadhaar Card, one driving license, (b) one iPhone 13 mobile handset along with one Airtel SIM card bearing mobile no. 7042598825 (as disclosed by him) and (c) one Redmi A2 mobile handset along with two SIM cards i.e. one Jio SIM card bearing mobile no. 6009090062 and one Airtel SIM card bearing mobile no. 8131068444 (as disclosed by him) were

recovered

(ii) Yumnam Ranbir Singh (51 yrs) S/o. (L) Y. Kuber Singh of Singjamei Makha Khongnang Pheidekpi, Imphal West District. From his possession, (a) one wallet black in colour containing a sum of Rs. 2000 - (Rupees two thousand only), one Aadhaar Card, one PAN card and one driving license. (b) one Samsung Galaxy A52 mobile handset along with two SIM cards i.e. one Jio SIM card bearing mobile no. 7005402239 and one Airtel SIM card bearing mobile no. 8974843878 (as disclosed by him). (c) one Samsung Duos mobile handset along with one Idea SIM card bearing mobile no. 9089859910 (as disclosed by him) and (d) one black side bag were recovered and

(iii) Khaidem Dhanabir Meitei (24 yrs) S/o. Kh. Modhuchandra Meitei of Lamlai Makha Leikai. Imphal East District. From his possession, (a) one wallet black in colour containing a sum of Rs. 5020/-Rupees five thousand and twenty only), one Aadhaar Card, one PAN card and one Voter card and (b) one Samsung S20<sup>-</sup> mobile handset along with two Airtel SIM cards/bearing mobile no. 6909270488 and

7629935166 (as disclosed by him) were recovered.

During preliminary verification, they disclosed that they are active members of KYKL organisation. Further, Khaidem Dhanabir Meitei disclosed that he started working for the said organisation since December, 2023 and he is presently working under the command of one significant organisation since December, 2023 and he is presently working under the command of one significant organisation. Commander Korou @ Thoithoi (Ph. No. 8730023952) of KYKL organisation and under the instruction of his commander he collected around Rs. 1,000,00/- (Rupees one lakhs only) from different contractors in and around Imphal area since January/February, 2024 and he further handed over the extorted money to his commander for their party fund. Further, Oinam Milan Singh and Yumnam Ranbir Singh disclosed that they are presently working under the command of the above mentioned Khaidem Dhanabir Meitei of KYKL organisation. Further, they disclosed that today i.e. 25/08/2024, they came in Changangei Uchekon area in a Hyundai Santro car (owned by the above mentioned Yumnam Ranbir Singh) for extortion activities and the said Hyundai Santro car golden in colour bearing registration number MN01K 6057 was found parked near the gate of the above mentioned New-Tech Nursing Home and the same car along with one vehicle Regd. Card bearing No. registration number MN01K 6057 which was registered in the name of Seikholet Khongsai S/o Late Sehkhopao Khongsai of Khongsai Veng, Imphal, Manipur was recovered from the spot at the instance of Yumnam Ranbir Singh.

Hence, Oinam Milan Singh, Yumnam Ranbir Singh and Khaidem Dhanabir Meitei were arrested from the spot at 01:12 pm, 01:16 pm and 01:21 pm respectively and the above recovered articles were seized at the spot at 01:14 pm, 01:18 pm and 01:23 pm respectively by observing formalities

Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
