No. HR67C-2857, along with my co-driver namely Rajkumar Sahani (23) yrs S/o Upender Sahani of Pohadi, Darbhanga, Bihar, PIN-847103 with loaded MDF Board amounting Rs. 5,05,920/- (Five Lakhs Five Thousand Nine Hundred twenty) only of Tirupati Traders, Ward No. 42 H/693/1 Bhabasandhu colony, 4th Mile Sevoke Roas, Siliguri, West Bengal coming from Lamlong side towards Khongnang Ani karak to delivered at Churachandpur.
