l, the undersigned, have the honour to lay down the following few lines for your kind consideration and favourable action:-

- 1. That, I am the President of an association in the name and style of "The Popular Pisciculture Association, Manipur at Lamphelpat".
- 2. That, I along with other members have been utilizing the farms inside the premises of the said Association near Minor Irrigation Office at Lamphelpat. The said farms are being utilized for rearing fishes, pigs, and cultivation of seasonal vegetables.
- 3. That, on 19-03-2024 at around 11 am some unknown persons of the proscribed members of one unlawful armed organisation came to my residence and gave a number i.e. 8131927768 and told me to call at that number. Then I call at that number on 20-03-2024 and the person on the other end told me that I should come at Langol on the same day at 2 pm or I will face dire consequences.
- 4. That, when I went to Langol at around 2 pm, after about one hour the said M. Dhanabir Singh along with one member of the said outfit [member of one unlawful armed organisation] came to the spot and the said M. Dhanabir Singh and his men threatened me to give an amount of Rs. 3 lakhs if I want to continue to stay as a President of "The Popular Pisciculture Association, Manipur at Lamphelpat". However, I told as I was not having any amount of money and to give some more time.
- 5. That, on 22-03-2024 and 23-03-2024 the members of the said outfit called me frequently and told me to give them a sum of at least Rs. 1.5 lakhs otherwise I will be given punishment and dire consequences will follow.
- 6. That, the illegal acts of the said persons connected with the proscribed members of one unlawful organisation has caused harassment and anxiety to me and may illegally cause harm to my person and property.

It is, therefore, requested your goodself to take up the matter promptly and book the above-named culprits in accordance to law.
