Subject: - Report.

Sir.

I have the honour to state that today i.e. 30/08/2024 at about 12:30 pm, a reliable information was received from our own sources about the presence of some active cadres of KCP (Taibanganba) organisation in and around Lamphel area with a view to commit prejudicial activities like extortion from Hospitals, Government Employees etc. Acting on the information, teams of CDO-IW led by Shri P. Achouba Meetei, MPS, OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation near Lamphel Traffic Island area. During that our team saw a person standing near Maruti Suzuki K10 car orange in colour bearing Registration No. MN05A 3899 in a very suspicious manner. Due to his suspicious nature, he was detained for spot verification and checking. During spot verification and checking, he identified himself as Laishom Sundar Singh (38 yrs.) S/o. Laishom Lokendro of Chairen Leingangtabi, Bishnupur District a/p Maibakhul Hangen Mapal, Imphal East District. From his possession, the following items were recovered: (i) one iPhone XR mobile handset along with one Airtel SIM card bearing mobile no. 8798136905 (as disclosed by handset mobile him), (ii) along with one Airtel SIM card bearing mobile no. 8974341889 (as disclosed by him), (iii) one brown side bag containing a sum of Rs. 35,000 /- (rupees thirty five thousand only) and (iv) one brown wallet containing a sum of Rs. 1,320/- (rupees one thousand three hundred and twenty) and one Pan card.

During preliminary verification, he disclosed that he is an active member of KCP (Taibanganba) organisation and started working for the said organisation since June, 2024 and presently working under the command of one s/s Commander Thouyangba (mobile no. 9233987315), Assistant Secretary Organisation of KCP (Taibanganba) organisation. He further disclosed that under the instruction of his commander, he along with his associate namely Thoudam Victor @ Bijen from Andro Machengpat of KCP (Taibanganba) organisation made monetary demands from private/public hospitals, shops etc in and around Imphal area. He also disclosed that earlier, they had collected around Rs. 12,000/- (rupees twelve thousand only) from the general public and the same amount was handed to their commander. He further disclosed that the above recovered amount i.e. Rs. 35,000 /- (rupees thirty five thousand only) was extorted from general public for their party fund and the above mentioned Maruti Suzuki K10 car was used in their party activities.

Hence, he was arrested from the spot at 01:47 pm and the above recovered articles along with one Maruti Suzuki K10 car orange in colour bearing Registration No. MN05A 3899 were seized from the spot at 01:50 pm by observing formalities.

Hence, the arrested person along with the seized articles is handed over to you for taking further necessary legal action against him.
