As per GD. Entry No. 36/LPS/2024 Dated 01/09/2024 regarding an information from MIKE 30 SP room that there had been seen as control room that there had been incident of firing by one person, one team of Lamphel police led by ASI T. Jiten has left for the spot i.e. Langjing Achouba Makha Leikai. On arrival, the person was identified as Waikhom Sekendar Singh aged about 43 yrs S/o W. Mangi Singh of Langjing Achouba Makha Leikai. Imphal West. Later the team picked him on the charge that he had shot 7/8 round in the courtyard and house of Thongbam Dijamani Singh aged (58) yrs S/o (L)Th. Suranjoy of Langjing Achouba Makha Leilai and seized a pistol on production by his wife namely Waikhom (O) Panthoi Devi. Medical test conducted on the said person at RIMS casualty and the CMO has opined that he was under the influence of alcohol. Later brought at the Lamphel PS.

In the meantime, one Ashokumar Ngariyenbam (40) yrs S/o (L) Ng. Temba Singh of Ghari Aware Leikai, IW (younger brother of the victim namely Thongbam (O) Ibemcha) made a compliant report of the same incident. He stated that his sister namely Thongbam (O) Ibemcha Langjing Achouba Makha Leikai has been gun pointed on her forehead attempting to murder by one neighbour namely Waikhom Sekendar. Also, the accused had shot 7/8 rounds of bullet attempting to murder her and her family. Following this inhumane incident her sister got unconscious and collapsed on the floor. Her daughter namely Thongbam Jiya aged about 13 yrs also got collapsed seeing all this situation. And both were evacuated to hospital for treatment.

The matter needed to be properly enquired within 14 days under Section 173(2) BNSS, 2023. During the enquiry I have sent for injury reports of both the victims and the MO concerned has opined that the nature of injury is simple. Further visited PO for examination and recorded the statement of Thongbam Dijamani Singh, Thongbam Ibemcha and other witness namely Longjam Shila Devi aged about 42 yrs W/o L. Tomba of the same locality. In the statement of the victim, it is revealed that on 1/09/2024 at about 7:30 pm, Sekendar had pointed the gun on her head in the near front door and luckily, she could escape. There is prima facie evidence of attempt to murder and illegal use of firearm.

So, I am therefore submitting this report for registering an FIR case against the accused person for smooth investigation of the case at the earliest.
