Subject: - Report.

Sir.

I have the honour to state that today i.e. 19/09/2024 at about 02:00 pm, a reliable information was received from our own sources about the presence of some active cadres of KYKL organisation in and around Ghari Awang Leikai area of Imphal West District with a view to commit prejudicial activities like extortion of money from the general public, shops etc. Acting on the information, teams of CDO-IW led by Shri P. Achouba Meetei, MPS, DSP(CDO)IW and i/c OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Ghari Awang Leikai, Imphal West District. During that three unknown persons were found standing near the gate of Manipur International University, Ghari Awang Leikai in a very suspicious manner. Due to their suspicious manner they were detained at the spot for verification and checking. During verification and checking, they identified themselves as:

1. Maibam Bronson Singh (24 yrs.) @ Ngamba @ Thambou S/o. (L) M. Inaocha Singh of Patsoi Part-III, Imphal West District. From his possession, the following items were recovered: (i) One black side bag containing one 9mm pistol along with one magazine loaded with one 9mm ammunition, (ii) one Galaxy A15 5G mobile handset along with two SIM cards i.e., (a) one Vodafone SIM card bearing mobile no. 7642013782 (as disclosed by him) and (b) one Airtel SIM card bearing mobile no. 8730941633 (as disclosed by him), (iii) one LAVA mobile handset along with one Airtel SIM card bearing mobile no. 7085652890 (as disclosed by him),

2. Yumnam Lanchenba (21 yrs.) @ Naoba S/o. Y. Dinachandra Singh of Lalambung Takhellambam Leikai, Imphal West District. From his possession, the following items were recovered: (i) One Vivo 1803 mobile handset along with one Airtel SIM card bearing mobile no. 6909577417 (as disclosed by him) and (ii) One HERO mobile handset along one Vodafone SIM

card bearing mobile no. 9774723586 (as disclosed by him) and

3. Soubam Nongpoknganba Meitei (52 yrs.) S/o. (L) S. Ibohal Singh of Uripok Khoisnam Leikai, Imphal West District. From his possession, the following items were recovered: (i) One iPhone 11 mobile handset along with one Jio SIM card bearing mobile no. 7005835353 (as disclosed by him) and (ii) one brown wallet containing a sum of Rs. 370/- (rupees three hundred and seventy) and one Aadhaar card.

During preliminary verification, Maibam Bronson Singh disclosed that he is an active member of KYKL organisation and started working for the said organisation since July, 2024 and presently working under the command of one s/s Commander namely Tamngakpa @ Yaima @ Sana (8638350985) from Kwakeithel area of KYKL organisation.

Again, Yumnam Lanchenba also disclosed that that he is an active member of KYKL organisation and started working for the said organization since August, 2024 and presently working under the command of the above-mentioned s/s Commander namely Tamngakpa (8638350985) from Kwakeithel area of KYKL organization.

Further, Soubam Nongpoknganba Meitei also disclosed that that he is an active member of KYKL organization and started working for the said organization since May, 2024 and presently working under the command of the above-mentioned s/s Commander namely Tamngakpa (8638350985) from Kwakeithel area of KYKL organization.

On further verification, both Maibam Bronson Singh and Yumnam Lanchenba disclosed that under the instruction of their commander they served monetary demands to stone crusher located at Sekmai side and shops located at Thangmeiband areas and collected around Rs. 50,000/- from the shops located at Thangmeiband and Lamphel area and the extorted money was handed over to their commander for their party fund. Further, Maibam Bronson Singh disclosed that he received the above recovered 9mm pistol from his commander around one week back to be used in extortion activities. He further disclosed that he also received one Maruti 800 car silver in colour from his commander to be used in their party activities. As pointed out by him, the said Maruti 800 car silver in colour bearing registration number MN02G 0403 was recovered

They further disclosed that today i.e., 19/09/2024 under the instruction of their commander, they came to Ghari Awang Leikai area in order to commit extortion activities.

Hence, they were arrested from the spot at 03:24 pm, 03:26 pm and 03:28 pm respectively and the recovered articles were seized from the spot at 03:30 pm, 03:32 pm and 03:34 pm respectively by observing formalities.

Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
