Subject:-Report.

With due regard, I have the honour to report that a reliable information has been received that some unknown persons have stormed at the residence Babloo Loitongbam, Human Right Activist of Kwakeithel Thiyam Leikai. Accordingly, an enquiry has been conducted by visiting the residence of Babloo Loitongbam at Kwakeithel Thiyam Leikai. On examination of Dr. Loitongbam Gourigopal (88) years F/o Babloo Loitongbam, he stated that on 23/09/2024 at about 10:10 am, some male youths numbering about 40 have arrived at their gate and more than 20 youths have entered the courtyard and asked him if there was someone other than him who can talk with them. He replied that they can talk to him. One from the unknown youths identified that they are the members of Meitei Leepun. Further, they said that your son Babloo Loitongbam was banned to come to public domain. However, he was organising Anti Meitei programme in public domain, if he does not stop coming to public domain, the family members will face dire consequence.

From the above facts, there is prima facie evidence that the unknown youths have committed cognizable offence which is punishable u/s 329(3)/351(3)/3(5) BNS 2023.

It is therefore submitted to register a regular FIR case for proper investigation.




