Subject: - Report.

Sir,

I have the honour to state that today i.e. 14/10/2024, based on a reliable information from our own sources and 4 AR about the presence of some active cadres of KCP (Nongdrenkhomba) organisation in an around Langol Game Village Zone III area with a view to commit prejudicial activities like extortion of money from the general public, shops etc., a combined Security team consisting of teams of CDO-IW led by Shri RK. Eden Singh, MPS, Dy. SP(Ops.) IW assisted by Subedar Ch. Surjit Kumar of CDO-IW and myself, a team of Lamphel-PS along with women police personnel and team of QAT CRPF under the command of Shri M. Amit Singh, Addl.SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW conducted a cordon and search operation at the said area from around 04:00 am. During the search operation at the house bearing Quarter No. TA-66 located at Langol Game Village Zone III, 7 (seven) unknown persons including 1 (one) unknown woman were found in a very suspicious manner. Due to their suspicious manner, they were detained at the spot for verification and checking.

During spot verification and checking, they identified themselves as:

1. Loushambam Alin Singh (26 yrs.) S/o. (L) L. Bayron Singh of Singjamei Oinam Thingel, Imphal West District a/p Langol Game Village Zone III, Quarter No. TA-66. During spot body search, one micromax X708 mobile handset along with one Airtel SIM card bearing mobile no. 9378028259 (as disclosed by him) was recovered from his possession.
2. Konsam Rohit Singh (23 yrs.) S/o. K. Gonendro Singh of Patsoi Part I, Imphal West District. During spot body search, one POCO M6 Pro 5G mobile handset along with one Jio SIM card bearing mobile no. 7005852049 (as disclosed by him) was recovered from his possession.
3. Sanju Wahengbam (20 yrs.) @ Lemba S/o. (L) W. Sanjoy of Palace Compound Mahabali Mamang, Imphal East District. During spot body search, one Vivo 1818 mobile handset along with one Jio SIM card bearing mobile no. 7005985442 (as disclosed by him) was recovered from his possession.
4. Phanjoubam Thoiba Mangang (26 yrs.) @ Malemnganba S/o. (L) Ph. Jiten Singh of Thongju Part II, a/p Wangkhei Tokpam Leikai, Imphal East District. During spot body search, one Galaxy A54 5G mobile handset along with one Jio SIM card bearing mobile no. 9366469593 (as disclosed by him) was recovered from his possession.
5. Waikhom Hero Meitei (21 yrs.) S/o. W. Iboyaima Singh of Takhel Mamang Leikai, Imphal East District. During spot body search, one Redmi 12 mobile handset along with one Airtel SIM card bearing mobile no. 8131046650 (as disclosed by him) and one Airtel loose SIM card bearing SIM card no. 8991160990024377872U were recovered from his possession.
6. Yanglemb Bikash Meitei (23 yrs.) @ Amujao S/o. (L) Y. Hemanta Singh of Singjamei Yanglemb Leikai, Imphal West District. During spot body search, one Redmi 13C 5G mobile handset along with one Vodafone SIM card bearing mobile no. 8794535468 (as disclosed by him) was recovered from his possession.
7. Henthobi Moirangthem (41 yrs.) @ Chan D/o. Moirangthem Kumar Singh of Uripok Gopalaji Leirak, Imphal West District a/p Langol Game Village Zone III, Quarter No. TA-66. During spot body search, one iPhone 12 Pro mobile handset along with one Jio SIM card bearing mobile no. 8837377514 (as disclosed by her) was recovered from her possession.

During preliminary verification, they disclosed that they are active members of KCP (Nongdrenkhomba) organisation and presently working under the command of s/s Chairman Nongdrenkhomba of KCP (Nongdrenkhomba) organisation. They disclosed that they were involved in extortion activities and threatening to general public in and around Imphal area under the instruction of their commander.

On further verification, Loushambam Alin Singh disclosed that the said quarter is presently occupied by him to be used for their party activities. He further disclosed that he received one Toyota Fortuner white in colour and some combat dresses and military equipments from his commander Nongdrenkhomba for using in their party activities and the same articles were kept in the said quarter.

As pointed out by him, (i) one Toyota Fortuner white in colour bearing number plate of vehicle regd. no. MN06LA 7346 (likely to be fake regd. no.), (ii) 3 (three) nos. of Khaki shirts, (iii) 1 (one) no. of camouflage cap, (iv) 1 (one) no. of Khaki Pant, (v) 3 (three) nos. of camouflage pants, (vi) 7 (seven) nos. of military combat camouflage shirts, (vii) 3 (three) nos. of military combat raincoat and (ix) 3 (three) nos. of camouflage shirt were recovered from the garage of the quarter at his instance. On further checking of the said Toyota Fortuner, 5 (five) nos. of vehicle number plates in which two number plates bear regd. no. AS01DE 9075, two number plates bear regd. no. WB 96J 3237 and one number plate bears regd. no. MN04G 2800 were also recovered. During further search at the garage, the following articles were also recovered : (i) one Hyundai Grand i10 white in colour bearing registration number MN01AG 8516 owned by Henthoibi Moirangthem (the above detainee), (ii) one Royal Enfield Classic 350 brown in colour bearing chassis no. ME3J3C5FGM2010140 owned by Waikhom Hero Meetei (the above detainee). He further disclosed that he also received two pistols and one realme mobile handset from one Anand from Pukhao of KCP (Nongdrenkhomba) organisation who is presently working as s/s Camp CO of Yaithibi Loukol, Sora on 10/10/2024. Further, he disclosed that he handed over one of the pistols to Phanjoubam Thoiba Mangang. As pointed out by him, (i) one pistol marked with "FORGAS TAURUS S. A. MADE IN BRAZIL PT 58 HC 380 ACP" along with one empty magazine, and (ii) one realme mobile handset were recovered from an almirah of the quarter at his instance. During verification of Phanjoubam Thoiba Mangang, he disclosed that he kept concealed one pistol in the right-side door storage box of the said Hyundai Grand i10. As pointed out by him, one pistol marked with body no. "28531" along with one magazine loaded with two rounds of 7.65 ammunitions was recovered from the said side door storage box of the said Hyundai Grand i10. While making further verification and searching, a crowd including local women folk/meira paibis and youths gathered at the spot and obstructed the procedure of verification and searching. During the scuffle, the crowd later turned violent and due to the current situation in Manipur, immediately, the detainees and the recovered articles were brought to Lamphel-PS for making further verification and necessary legal procedure. On arrival at Lamphel-PS, 1. Loushambam Alin Singh, 2. Konsum Rohit Singh, 3. Sanju Wahengbam, 4. Phanjoubam Thoiba Mangang, 5. Waikhom Hero Meetei, 6. Yanglem Bikash Meitei and 7. Henthoibi Moirangthem were arrested at Lamphel-PS at 2:02 pm, 2:05 pm, 2:07 pm, 2:09 pm, 2:11pm, 2:13 pm and 2:15 pm respectively and the above recovered articles were seized at Lamphel-PS by observing formalities. Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.


