Sub:- Report against the Branch Head of Axis Bank Ltd, Imphal Branch, Thangal Bazar and the Proprietor of the M/S Kakum Enterprise, GSTIN- 12ACQPY8997A1ZW, having its Office at d-Sector, Opposite of M.E. School, Itanagar, District-Papum Pare, Arunachal Pradesh 791111, namely, Sunday Bengia whose Pan Card number is GOYPB4340J.

Sir.

With due respect, I, the undersigned, beg to report to you since the City Police Station, Imphal, refuse to accept my written report dated 10-10-2024. The facts of the complaint is:

- 1. That, on 23-9-2024, DEED OF AGREEMENT FOR SUPPLY OF GOODS was executed at Imphal, between the said M/S Kakum. Enterprise and M/S IK Soibam and Sons to which I am the Proprietor, for the supply of agricultural items to the said M/S Kakum Enterprise by us (M/S IK Soibam and Sons) of the value of Rs.9.83,57,500.
- 2. That, by virtue of the said agreement, the said M/S Kakum Enterprise handed over to me a DEMAND DRAFT (issued by the SBI Itanagar Branch) dt. 25-9-2024 of the amount of Rs. 4,90,00,000/- on 30-9-2024 first for purchasing from us (M/S IK Soibam and Sons) agricultural items at my office M/S IK Soibam and Sons located at Ghari Awang Leikai near Xtra Edge School Thereafter, on the same day, I deposited the said DEMAND DRAFT in the Axis Bank Ltd, Imphal Branch, Thangal Bazar.
- 3. That, w.e.f. the 2nd Oct,2024, I commenced supplying of goods till the 4th Oct,2024 upon the M/S Kakum Enterprise by us by issuing necessary invoice.
- **4.** That, very surprisingly, on 5-10-2024, my current account bearing A/C No. 922020027439950 of the Axis Bank Ltd, Kwakeithel Branch and all my business transactions were found put on hold without justification.
- 5. That, on my inquiry on 9-10-2024, I came to know that the put on hold of my said current account and all my business transactions was done by the Branch Head of Axis Bank Ltd, Imphal Branch, Thangal Bazar I made all my necessary inquiry to know the reasons for putting on hold of my bank transactions and late in the evening, I further came to know that the said act was done by the Branch Head of the Axis Bank Ltd, Imphal Branch, Thangal Bazar, in connivance with the said proprietor M/S Kakum Enterprise D-sector, opposite of M.E School, Itanagar, Arunachal Pradesh.
- 6. That, the unreasonable actions of the Branch Head of the Axis Bank Ltd, Imphal Branch, Thangal Bazar, has thus caused uncounted lass to my business for I can no longer made any money transactions for my business for which both the Proprietor of the M/S Kakum Enterprise and the Branch Head of the Axis Bank Ltd, Imphal Branch, Thangal Bazar, are held liable.

I, therefore, request you for taking up necessary legal actions against these two persons for having caused uncountable loss to me and for defaming me without any justification.
