REPORT: RECOVERY & SEIZURE OF ILLEGAL
ITEMS

I hereby submit the report that based on inputs of movement of contraband in areas across borders and its likelihood of crossing over to Indian side as also drone sightings in areas in immediate proximity of borders, a search party was launched at 0700 hours on 10 August 2024 under Company Commander, Chappol COB.

While searching the areas around borders, a dugout was identified by the tracker dog at around 1230 hours at GR 707976 (approx 100mts West of Indo Myanmar Border onto own side). In the dugout, the following items were recovered :-

- (a) 20x soap cases containing suspected brown sugar
- (b) 100x Detonators
- (c) 01x 5mts safety fuse

The above mentioned items are being packed and handed over to Chakpikarong Police Station for further proceedings.
