LODGING OF FIR

1. It is to inform that at around 0145 hours on 09 September 2024 a team of one Junior Commissioned Officer and 20 Other Ranks led by an Officer from COB Kachinbung was on area domination patrolling along Indo-Myanmar border. The patrolling observed one unidentified person roaming in the jungle of Pt 1699 which is three kilometers (Km) inside own territory at around 0315 hours on 09 September 2024. The patrol challenged him to establish his identity and was warned not to run. Then, the individual was apprehended and found out that he could not prove his identity and did not possess any documents with him. The person was brought to COB Kachinbung at 0410 hours on 09 September 2024 and on preliminary investigation the individual revealed that he is from Myanmar and lost his way while moving in border area inside Myanmar territory.
