

Sir,

As per direction from the Superintendent of Police Chandel District, Manipur a joint team consisting of Chandel District Police, 1st Assam Rifles and villagers of Molagat conducted illicit poppy destruction at a secluded place closed to B.P 530 Indo-Myanmar international border on 30-11-2024. which, approximately 10 (ten) acres of cultivated illicit poppy were destroyed. The culprits (cultivator) behind the cultivation were not known and highly suspected to be adjacent Myanmar Nationals.
