Sir,

Most humble and respectfully, I beg to state the following few lines for favour of your kind and necessary action.

- 1) That, I am a farmer and a residence of Nakhujang village, Lamsang, Saitu Gamphajol Sub-Division, Kangpokpi District and the village Chief is Mr. Khuptinhang Vaiphei @Sk Vaiphei.
- 2) That, Nakhujang village is located in close proximity with Meitei community and Meitei settlement lies on the other side of the road. As the conflict started on 03/05/23 in the evening Arrambai started assemble at Kadangban village and it was not safe to stay in the village any longer. So all the villager including us fled from the village to nearby forest at night on 03/06/23. We continued to stay in the forest till 06/05/23. When we got information about the arrival of Assam Rifle to our village, we went toward our village and eventually evacuated to the Assam Rifle camp at Kangchup Geljang village. After staying for a week in the Assam Rifle camp we were evacuated to Sapermeina.
- 3) That, while we were staying in Sapermeina my wife was seriously ill. We didn't expect the conflict to last this long and we were hoping to get her treated in Imphal as and when the situation gets better. However, the conflict didn't come to end as expected. As my wife needed urgent medical care my daughter Ms. Chacha who was in Chennai working in a company told us to come there for my wife treatment. So, we to Chennai in May last week 2023 where we remained there until recently.
- 4) While we were in Chennai undergoing treatment, we heard that Nakhujang village was attacked by Arrambai Tengol and Meitei militant on 02/06/23 and 03/06/23. My house was burned on 03/06/23 between 4:00 pm to 5:00 pm. My vehicle Bolero MN05A/1997 and two wheeler MN01Y 1611 parked at my residence was also burned by the attacker. Total cost of properties destructed is estimated to be approximately Rs. 30,00,000/ (thirty lakh)

I couldn't report the matter in time as we were in Chennai undergoing my wife medical treatment. It is therefore requested to kindly take cognizance of the crime and take further n/a.




