**First Information contents:** In response to SP/Ukhrul order no. C-1(G/P)/2024-SP(UKL)/9533 dated 07/12/2024 a combined team of Ukhrul District Police, 6<sup>th</sup> Bn. Manipur Rifles, 18<sup>th</sup> Assam Rifles and District Forest Department led by Shri Ringthing Hongchui, MPS, ASP (Ops), under the supervision of Superintendent of Police, Ukhrul conducted illegal poppy destruction at Phalee hill range on 16/12/2024 to 18/12/2024 at 10:00 a.m to 4:00 p.m by the order of the Magistrate on duty who furnished Attachment and Destruction order of Illicit poppy cultivation in the said area U/S 18(b) ND & PS Act, 1985 (as amended). An area of about 115 (one hundred fifteen) acres approximately was destroyed. It is expected to yield about 1150 (one thousand one hundred fifty) Kg, 10 Kg per acre of opium (Approx). None came forward to claim the ownership of the cultivated land. Thus, seized some poppy pods for inducing into evidence (if required) in the Court and for further legal action.

Hence, a Suo- Moto case under **FIR No. 02(12)2024/LM-PS, U/s 18 (b) ND & PS Act** was registered and endorsed to ASI. CL. Mathew for investigation.
