**First Information contents:** Today i.e., 06/11/2024 at 09:49 a.m., received a reliable information that a hand grenade was found planted/kept on the main entrance gate of the Office of the ZEO (Zonal Education Officer), Govt. of Manipur. On receipt of the information, our police party on patrolling duty, rushed to the spot and cordoned off the area for public safety. Bomb Disposal Squad from CID (Tech), Imphal was also informed for safe retrieval and disposal of the hand grenade. so far, no individual or group claims responsibility for the commission of the crime. Extensive man-hunt is on to arrest the involved culprits. In connection with the incident stated above, a suo-moto case under FIR No. 22 (11) 2024/UKL-PS U/S 109/113(1)(a)/308 (4)/3(5) BNS Act and 4 Expl Subs Act is registered for investigation.
