First Information contents: ASI. Yokshim Mahak of UKL-PS reported to OC/UKL-PS stating that With reference to the Superintendent of Police, Ukhrul order vide No.C-1(G/P)/2024-SP(UKL)/9488 dated 5th December 2024, a combined team of Ukhrul Police Station, Chingai Police Station, Reserve Line and Women Police led by Shri. Hopeson Chiphang, MPS, SDPO/Ukhrul conducted a secret operation at the Hill ranges of Khamasom Village, Ukhrul District in the intervening night of 06/12/2024 and 07/12/2024 under the supervision of SP/Ukhrul and ASP

PERST IN CRUTH MICH REPORT

In the early morning of 07/12/2024, self along with two other officers and 12 (twelve) police personnel climbed up the hill top as advanced team to detect presence of illicit poppy cultivators. After a (3) three hours climbed, the team reached Khamasom hill top at about 4:30am. There, a vast hill track of illicit poppy cultivation of around 30 acres were detected. On seeing our (Police) team approaching the poppy fields, 4 (four) poppy cultivators who were already awake ran away and when our police team tried to chase them, they all disappeared in the jungle. However, at around 6:00 am, 4 (four) individuals mentioned below were caught from one of the poppy fields while trying to ran away. On preliminary enquiry, they admitted to be the owner and cultivator of that illicit poppy fields measuring around 10 (ten) acres. It is expected to yield about 100 (hundred)kgs (i.e. 10kg per acre) of opium. They disclosed

During body search of the three men, one knife each were recovered from the body of Mr. Peimi Ramrak (27) and Mr. Kapangkhui Khashim (21), and one Air gun was recovered from the possession of Mr. Lightson Shimrah (49).

Further, I immediately informed SDPO Ukhrul, Women Police team and Executive Magistrate on duty about the detention of the four poppy cultivator and owner of the poppy field. Thereafter, seized some poppy pods from the poppy fields as evidence and for further legal action and came down along with the apprehended persons.

Therefore, all the 4(four) arrested individuals along with the seized items i.e., knives. Air gun and poppy pods are handed over to OC Ukhrul PS on 07/12/2024 at 03:00 pm. On being handed over the accused persons, the seized items and other relevant documents of the accused persons, the Officer-in-Charge, Ukhrul Police Station registered a regular case under FIR No. 23(12)2024/UKL-PS u/s 18(b)/29 ND & PS Act & 14 Foreigners Act and
