## 11. First Information contents:

In continuation of 'War on Drug' today i.e 21/12/2024, from 10:00 a.m. to 3:00 p.m. a combined team comprising of Ukhrul District Police, District Forest Department, Ukhrul, C-Coy 40 Bn BSF, 8<sup>th</sup> Bihar Regiment Litan Post, 6<sup>th</sup> MR and SDC/Executive Magistrate, DHQ/Ukhrul led by Addl. SP(Ops)/Ukhrul, conducted illegal poppy destruction drive at the Shongphel hill ranges, Latitude - 25.05413°N and Longitude - 94.128189°E. About 55(fifty-five) acres of poppy plantation was destroyed with an estimated value of RS.4,40,00,000/- (four crore forty lakhs only) approximately. While destructing poppy plantation, no one was found in the poppy field. Seized some suspected poppy pods from the field for inducing evidence.

Hence, a regular case on suo-motu under FIR No. 4(12)2024 LTN - PS U/S 18(b) ND & PS Act, has been registered for investigation.
