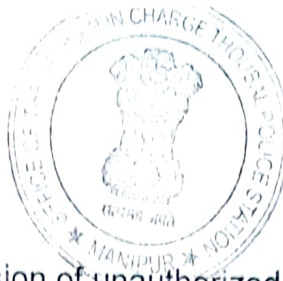

Subject : Report for possession of unauthorized firearm.

Sir,

I have the honour to report that during investigation of FIR No. 101/TBL-PS/2024 dated 02/10/2024 u/s 325/3(5) of the BNS, 2023, 25(1-B) Arms Act added 331(7) of BNS, 2023, a request for authentication of one Gun license bearing UIN 225242869956762023, License No. 4315 DM/SPT which was issued by the Addl. District Magistrate, Senapati, Manipur vide order No. DM/SPT II/176(GL)23(B) dated 17/11/2023, belonging to one accused person, namely Khundrakpam Somarjit Singh (39) yrs S/o Kh. Radhamani Singh of Khangabok Laipat Leikai, PO & PS- Thoubal, District-Thoubal was send to The Deputy Commissioner Senapati through The Office of Sr. Superintendent of Police, Thoubal vide Thoubal PS Memo No. 1641/TBL-PS/2024 dated 08/10/2024 r/w Sr. SP/Thoubal Memo No. 3/2/2024/SP-TBL/990 dated 08/10/2024. As per the reports received from Sr.SP/TBL vide Memo No.3/2/2024/SP-TBL/7739 dated 13/10/2024 read with DC/SPT vide Memo No. DC(SPT)3/12/92(pt-1):/848 dated 10/10/2024, it is learnt that no such licence mentioned above was issued in his name i.e. the gun licence as fake/forged document which was acquired fraudulently. A 12 bore pump action gun was purchased by producing the fake License on 15/06/2024 from M/S NONGTHOMBAM GUN HOUSE AMRS & AMMUNITION DEALER located at Ayangpali, Porompat Imphal, District Imphal East, Manipur. Further, no entry was also made with the DC Senapati after purchasing the weapon.
