Najvuddin of Hayel Labuk (8787548065) bearing consumer No./ Meter No. 555548807305 was inspected by the authorized Inspecting Officer(s) of MSPDCL along with the checking party on 22/10/24 at 1 AM/PM. The inspection report for offence of theft under section-135 of Electricity Act, 2003 is enclosed herewith.

During the above inspection, the following Act(s) of Theft/dishonest use of electricity was noticed as Meter-by passing/ Meter tampering/Double service line /Un-authorized use of electricity/Sublet of electricity/the purpose other than for which the usage of electricity was authorized eg. Commercial purpose in lieu of Domestic purpose.
