Sir,

I have the honour to report that on 26/10/2024 at around 5:00 pm, while my cousin brother namely Yumnam Alison Singh (21) yrs S/o Y. Inaocha Singh of Wangjing Tekcham Leikai was riding one Honda Activa B/Regn. No. NIL towards Thoubal side from Wangjing side met an accident with one Maruti 800 car B/Regn. No. NIL driven by Khundrakpam Rishikanta Singh (26) yrs S/o Kh. Ibobi Singh of Khangabok Khullakpam Leikai which was suddenly crossed the temporary divider along NH 102 near MMRC Park, Khangabok due to rash or negligent driving on the part of the Maruti 800 driver namely Khundrakpam Rishikanta Singh. As result of it, my cousin brother was received serious injury on his person and evacuated Hospital for giving medical treatment as well as both the vehicles were partly damaged.

This report was unable to submit in time due to my cousin brother was undergoing medical treatment at RIMS Hospital, Imphal.

It is, therefore, requested to kindly take up necessary legal action regarding the matter.
