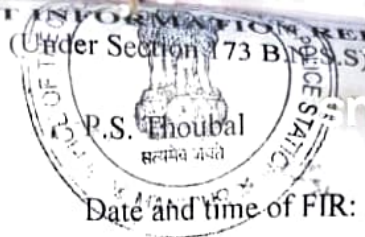

First Information contents:

Today i.e 11/11/2024 at 08.00 pm, received information that on the same day at around 07.50 pm, one Honda Activa 6G red in colour bearing regn.
