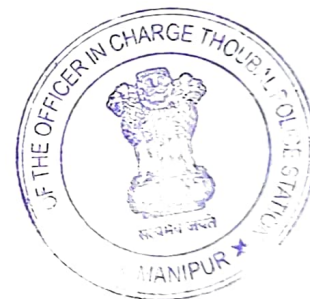

Sir,

As endorsed vide GD Entry No. 18/TBL-PS/2024 dated 08/11/2024, I have conducted thorough inquiry into the matter and the complainant namely Md. Kamaruddin, 60 years S/o (L) Sanajaoba of Wangkhem Bazar was examined and from his statement, it is learnt that his son namely Md. Mustaque, 22 years who was said to had been abducted on 31/10/2024 at around 6:30 pm from Wangjing Bazar in front of SBI, Wangjing Branch and later escaped from the clutch of the abductors has not returned back home till date. Further, the complainant stated that as his son was escaped, he thought his son will come back home and so he had submitted a report to this PS on 08/11/2024 at 5:30 pm to recover One mobile Phone having mobile no. 7628015513, a Laptop and a Maruti Swift Car that were snatched by the unknown persons from his son.

From the inquiry so far conducted, it is learnt that the said Md. Mustaque, 22 years has not returned back home till date and where about of him is still unknown and also the above mentioned items could not be trace out.
