I have the honour to report that today i.e. 19/11/2024 at about 9 am, all the members of my family left home for attending shradha ceremony of my demise grandfather held at Mayai Leirak Community Hall and all doors and windows of my house were properly closed and locked. After the shradha ceremony was over, we returned home on the same day at about 2:10 pm. When entering inside the house, my bedroom was found ransacked and the following items were also found stolen away by unknown persons who entered inside after breaking the window while there were no family members and it may happen in between 10 am to 11:30 am. The items are:

- 1. Rs. 2,70,000 (two lakh seventy two thousand) in cash kept inside wooden almirah
- 2. Gold ornaments of 4 Sans worth Rs. 92,000 (ninety two thousand)
- 3. Some other items

The total stolen amount would be of Rs. 4,00,000 (four lakhs)

It is therefore, requested to take up necessary action in this regard.
