Today i.e. 24/11/2024 at about 10:50 am, received an information that on the same day at about 10:40 am, one motorcycle Royal Enfield bearing regd. no. NIL red in colour proceeding from Thoubal towards Imphal side along NH102 knocked down one unknown male pedestrian at Waithou near the house of L. Kadamjit Singh while the pedestrian was crossing the highway due to rash or negligent riding on the part of the unknown rider of Royal Enfield. In that, the unknown pedestrian, unknown rider and its one unknown pillion rider of the Royal Enfield sustained injuries and evacuated to District Hospital, Thoubal for medical treatment however, the pedestrian was declared brought death. The motorcycle Royal Enfield was partly damaged.
