Subject: Request for Immediate Police Action and Night Duty at Public Ground, Khangabok Part-III Cherapur situated at the front of Khangabok Moirang Palli Outpost.

Respected Sir,

I am compelled to draw your kind attention to the urgent need for police intervention at the Public Ground, Khangabok Part-III Cherapur, situated in front of Khangabok Moirang Palli Outpost. As the Secretary General of the All Khangabok Sports Development Organization (AKSDO), Khangabok I'm requesting immediate action to address the series of damages and losses we've suffered.

Our sports academy, AKSDO, is dedicated to producing high-quality players from our village and providing facilities for grassroots players to pursue their careers in sports. We have been actively involved in promoting cricket in the region and have successfully hosted several state tournaments under the supervision of Manipur Cricket Association. In fact, we are currently hosting the MNCA tournament at the same ground, which has been ongoing for the past three seasons, with over 100 state tournament matches held successfully.

Unfortunately, our efforts have been hindered by repeated incidents of vandalism and theft. The latest incident occurred the day before yesterday night, November 24, 2024, when unknown persons tore apart our pitch cover, issued by the Manipur Cricket Association, covering an area of 100 sq. ft. at the center pitches. This is not an isolated incident; we've suffered a series of losses, including:

- Stolen and damaged property:

- Pitch cover torn apart

- Boundary rope (200m length) stolen
- Practice nets stolen and tom apart
- Sight screens stolen and torn apart
- Petrol water pump with pipe stolen
- Flag posts stolen (over 50)
- Kit bag with full equipment worth ₹40,000 stolen

In light of these incidents, I kindly request you to take immediate action and deploy police personnel for night duty at Moirang Palli Outpost, Khangabok. This will not only help prevent future incidents but also support the development of sports in our state.

As per the Police Act, it is the duty of the police to maintain law and order, prevent crimes, and protect public property. I urge you to exercise these powers to ensure the safety and security of our sports academy and its assets.

Thank you for considering our request. We look forward to your prompt response and action.
