I am to report on 03/12/2024 probably between 11.00 am to 2.00 pm, I kept/placed my 6 nos. of cows includes 2 nos. of cow, 2 nos. of calf & 2 nos. of heifer at the premises of Waithou Fishery farm located at Tangjeng near Water Supply after tying them by rope. In the evening of same day around 4.00 pm, I went there to pick-up the cows and found that 2(two) nos. of female Heifer (one is white & another maroon in colour) were found missing at there and could not trace it out despite of my efforts put into the same.
