

Today i.e. 26/12/2024 at 11:40 am received information that on the same day at around 11:30 am, one Suzuki Access B/Regn. No. MN04D-2643 ridden by an unknown rider which was coming from Thoubal Wangmataba side towards Thoubal Bazar side in wrong direction met an accident with one Honda Activa 5G B/Regn. No. MN04D-9790 ridden by an unknown rider along NH 102 at Thoubal Wangmataba in front of the Punjab and Sind Bank, Thoubal Branch due to rash or negligent riding on the part of the unknown rider of Suzuki Access B/Regn. No. MN04D-2643. As a result of which the unknown rider of Honda Activa sustained injury on his person and evacuated to Hospital for giving medical treatment as well as both the vehicles were partly damaged.
