Sir,

With due regards, I beg to state that today on 15/10/2024 at about 03:15 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foothill of Leirongthel Pitra Uyok Ching for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 5/9 Gorkha Rifle led by Insp. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 04:30 a.m. On searching and found the undernoted articles i.e. (1) 1 (one) No. of 12 mm bore Single Barrel gun bearing registration No. L-5079, (2) 1 (one) No. of AK 56 with magazine bearing registration No. 17270698, (3) 1 (one) No. of 7.62 SLR with magazine bearing registration No. 651379M, (4) 1 (one) No. of 9 mm SMG Carbine with magazine bearing registration No. 18266365, (5) 1 (one) No. of 9 mm pistol with magazine bearing registration No. D-7534, (6) 6 (six) Nos. of 36 Live Hand Grenade (which can be use as explosive), (7) 30 (thirty) Nos. of 7.62 X 39 mm live rounds, (8) 20 (twenty) Nos. of 7.62 mm live rounds, (9) 2 (two) Nos. of detonator, (10) 2 (two) Nos. of 12 bore live cartridge, (11) 2 (two) Nos. of tube launching, (12) 6 (six) Nos. of 9 mm Live rounds (13) 1 (one) No. of walkie talkie (Baofeng) handset with charger, (14) 1 (one) No. of BP jacket, (15) 2 (two) Nos. of BP iron plate and (16) 5 (five) Nos. of Arming Ring from the spot and seized at 05:18 a.m. The massive searched Operation was conducted from 4:30 a.m. to 6:30 a.m. on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
