With due regards, I beg to state that today i.e. 19/10/2024 at about 04:00 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives substances at the foothill of Irong hill near S.T.N.B.A. gate for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 165 INF Bn (TA)(H&H) Assam led by Insp. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 04:30 a.m. On searching and found the undernoted articles i.e. (i) 1 (one) no. of 9 mm Pistol (Country made) along with magazine, (ii) 2 (two) nos. of SLR magazine, (iii) 2 (two) nos. of INSAS magazine, (iv) 2 (two) nos. of 36 HE Hand Grenade, (v) 1 (one) no. of detonator, (vi) 2 (two) nos. Chinese Hand Grenade, (vii) 6 (six) nos. of 9 mm live rounds, (viii) 6 (six) nos. of 7.62 mm live rounds, (ix) 1 (one) no. of Tear Smoke Shell Soft Nose, (x) 1 (one) no. of Smoke Grenade, (xi) 1 (one) no. of Cartridge 38 mm Anti Riot with Rubber Bullet, (xii) 1 (one) no. of Stinger Cartridge, (xiii) 3 (three) nos. of 9 mm empty case & (xiv) 3 (three) nos. of 7.62 mm empty case from the spot and seized at 05:37 a.m. The massive searched Operation was conducted from 4:30 a.m. to 6:30 a.m. on the same day.
