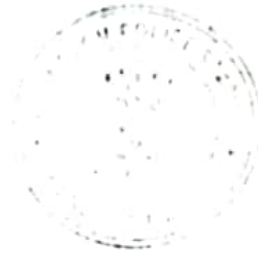

Today ie.17/10/2024 at 6.20 pm received a reliable information that on the same day at 6.10 pm, one Honda Activa red in colour bearing Regd No MN06S-B-5044 ridden by an unknown driver coming from Wangjing side towards Khongjom bazar knockdown an unknown pedestrian along NH102 near GDS brick field due to rash and negligent driving on the part of Honda Activa. As a result, the rider and pedestrian sustained injuries on their persons whereas the pedestrian seriously injured and evacuated to Hospital for medical treatment. The accident vehicle got partly damaged.

Hence a regular *suo-motu* case under FIR No. 26 (10)2024 KJM PS U/S 281/125(b) /324(4) BNS 2023 has been registered for investigation.
