Subject : Report.

Sir,

With due regards, I beg to state that today i.e. 23/10/2024 at about 04:00 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives substances at the foothill of Kwarok Maring for offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 4 AR COB Thoubal led by Insp. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 05:00 a.m. On searching and found the undernoted articles i.e. (i) 1 (one) no. of 9 mm Pistol (Country made) along with magazine, (ii) 1 (one) no. of SBBL bearing registration No. 28180-12, (iii) 2 (two) nos. of Tube Launching, (iv) 2 (two) nos. of 36 HE Hand Grenade, (v) 1 (one) no. of INSAS Magazine, (vi) 3 (three) nos. 12 Bore Cartridge, (vii) 3 (three) nos. of 9 mm live rounds, (viii) 10 (ten) nos. of 7.62 mm empty case and (ix) 1 (one) no. of Baofeng Radio set were found from the spot at 05:15am hence the above noted articles were seized at 05:20 a.m. The massive searched Operation was conducted from 05:00 a.m. to 06:35 am. on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
