Sir,

With due regards, I beg to state that today i.e. 26/10/2024 at about 04:00 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives substances along foot hill of Tentha Tuwaband area for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 33 AR led by Inspt. K. Nitaranjan Singh, OC/CDO-TBL Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Senior superintendent of Police, Thoubal rushed to the spot immediately and launched a massive operation at 05:00 a m. On searching the undernoted articles i.e. (1) 1(one) no. of 7.62mm Sniper Rifle bearing registration no. 38605, (2) 5(five) nos. of 9mm pistol made in Burma bearing registration numbers (i) K-8471, (ii) K-6925, (iii) A-5841, (iv) K-0894 (v) G-6285, (3) 5(five) nos. of 36 HE Hand Grenade (can be use as explosives), (4) 2(two) nos. of 2" Mortar Shell, (5) 2(two) nos. of Tube Launching, (6) 6(six) nos. of Stardyne 90 Explosive(125) gram each), (7) 4(four) nos. of Electronic Detonator, (8) 15(fifteen) nos. of 9mm live rounds, (9) 2(two) nos of 7.62 mm live rounds, (10) 1(one) no of 5.56mm live round, (11) 2(two) nos. of 12 Bore Cartridge, (12) 2(two) nos of Tear Smoke Shell (SR), (13) 1(one) no. of Gas Gun Shell, (14) 1(one) no. of Tear Smoke(LR), (15) 2(two) nos. of Miniflare cartridge (16mm) and (16) 1(one) no. of Baofeng Radio Set were found from the spot at 05:47 a.m. Hence the above noted articles were seized at 6:00 a.m. by observing formalities. The massive searched operation was conducted from 05:00 a.m. to 06:30 a.m. on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action
