With due regards, I beg to state that today i.e. 24/10/2024 at about 04:10 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives substances at the undergrowth of B. Phainom village for offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 4 AR COB Chandrakhong led by Insp. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 04:30 a.m. On searching and found the undernoted articles i.e. (i) 1 (one) no. of SMG Carbine along with magazine bearing registration no. E&C122572, (ii) 1 (one) no. of Pompi gun/RL, (iii) 2 (two) no. of SMG Carbine Magazine, (iv) 1 (one) no. of 36 HE Hand Grenade, (v) 1 (one) no. of Arming ring, (vi) 3 (three) nos. 9 mm live round, (vii) 10 (ten) nos. of 5.56 mm live rounds, (viii) 1(one) no. of detonator ix) 2 (two) nos. of Tear Smoke Shell soft nose (x) 1 (one) no. Dye marker grenade, xi) 1 (one) no. of 38 mm anti- riot rubber bullet and xii) 2 (two) nos of Boafeng radio set were found from the spot at 05:15 am hence the above noted articles were seized at 05:23 a.m. The massive searched Operation was conducted from 04:30 a.m. to 06:30 am. on the same day.
