Subject : Report.

Sir,

With due regards, I beg to state that today on 04/12/2024 at about 3.50 a.m received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at foothill of Fungei Ching, Ngamukhong for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 5/9 Gorkha Rifle led by Inspt. K. Nitarnjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 4:30 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 1(one) no. of SLR Rifle along with magazine bearing registration No. 16255019, (2) 1(one) no. of SMG Carbine along with magazine bearing registration No. 13035, (3) 1(one) no. of 12 Bore Double Barrel bearing registration No. Pi2988, (4) 1(one) no. of 9mm Pistol along with magazine bearing registration No. E4321, (5) 1(one) no. of .32mm Pistol along with magazine bearing registration No. E4058, (6) 6(six) nos. of 36 HE Hand Grenade(can be used as explosives), (7) 2(two) nos. of Detonator, (8) 2(two) nos. of Tube Launching, (9) 20(twenty) nos. of 7.62mm live rounds, (10) 13(thirteen) nos. of 9mm live rounds, (11) 2(two) nos. of .32mm live rounds, (12) 4(four) nos. of 12 Bore Cartridge, (13) 5(five) nos. arming ring and (14) 1(one) no. of Walkie Talkie Baofeng radio set with Charger from the spot at 5:46 am. The massive searched Operation was conducted from 4:30 am to 7:00 am on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
