12. First Information contents:



Today i.e. 03/11/2024 at 05.20 pm received a reliable information that on the same day at around 05.10 pm, one DATSUN REDI-GO, red in colour bearing registration no. MN06LB-2626 driven by an unknown driver plying from Khongjom Bazar side towards Wangjing collided with 02(two) Honda Activa viz. Honda Activa 6G, grey in colour, bearing registration no. MN01AN-2403 and Activa 4G, white in colour, bearing registration no. MN01AD-8493, respectively, both ridden by unknown riders, which were coming from Wangjing side towards Khongjom Bazar, at the front of the gate of Khongjom Standard English School, Sivanagar, Khongjom, along NH No. 102, due to rash or negligent driving on the part of unknown driver of DATSUN REDI-GO. As a result of which, the 02(two) unknown riders and 02(two) unknown pillion riders of both the Honda Activa sustained injuries on their persons and evacuated to hospital for medical treatment. And the DATSUN REDI-GO car and the Honda Activa bearing registration no. MN01AN-2403 were damaged.

Hence a regular suo-motu case under FIR No. 29(11)2024 KJM PS U/S 281/125(b) /324(4) BNS 2023 has been registered for investigation.
