Sir,

With due respect, I am to state that I, the undersigned, along with my families have left my village along with our properties which include land (homestead & Hill land) at Nongmaiching Tampak/Haukhongphai Village, Kangpokpi District, Manipur, on 4th May 2023 due to the ongoing ethnic violence that erupted the state since 3rd May 2023.

That on 7th November, 2024 at around 10 AM, I came to learnt that our Deserted homestead Land and Hill land have been encroached and illegally Levelling the ground with Bull Dozer by unknown persons suspected to be a villagers of Nongpok Sekmai and sympathizer of Arambai Tenggol for farming purpose. The encroachers have also begun unauthorised clearing of trees and construction of roads (Cutting new Road) in my Hill Land areas.

In view of the above facts and circumstances, I kindly request the concern Police Station to take immediate action as per the law and urge you to conduct a thorough investigation to identify the individuals involved in this unlawful activities and implement measure to halt further development or unauthorized use of the land. Prompt action from your esteemed office will help restore order and prevent further damage.
