As such on my way home I slightly show something coming towards me, so I put on my torch light to identify it, in that I could identify the one coming towards me as one Khumukcham Itocha Singh aged about 41 years, S/o (L) Kh. Balloon Babu Singh of Samaram Makha Leikai, just in front of the gate of the damage house of Irengbam Rupachandra Singh located at Samaram Mayai Leikai along the IVR of Samaram to Chingtham road. Then he shouted towards me using abusive words alleging me that I had put my torch light on his face, however I clarify him as I did not do it intentionally. But he did not listen to me and took out a small arm from him and fire a round towards my head with an intention to kill me, however it is very fortunate that I was not hit by his bullet, and had escaped from the spot by taking the advantages of the darkness.

In this regard your good-self is requested to kindly take up necessary legal action against the culprit as per admissible law since the act of the culprit was so wild that he could attempt the life of innocent persons and may continue in the future.
