## 12. First Information contents:

Today i.e. 17/12/2024 at 02.30 pm received a reliable information that on the same day at around 02.10 pm, one Honda Activa, black in colour bearing Registration No. MN01U 2114 playing from Wangjing side toward Kakching side ridden by one unknown rider, collided with another Honda Activa, black in colour bearing Registration No. MN01U 2114 plying from Kakching side towards Khongjom Bazar side driven by unknown driver, near the gate of Khangemba Shanta Singh of Khongjom Bazar, along NH No. 102, due to rash and negligent driving on the part of both the unknown ridders of the vehicles. As a result of which both the unknown riders and the pillion ridders of both the vehicles sustained injuries on their person and evacuated to District Hospital Thoubal for medical treatment. However the unknown ridder of Honda Activa, black in colour bearing Registration No. MN01U 2114, is declared to be brought dead by the concerned doctor of District Hospital Thoubal. And both the vehicles were also badly damaged.

Hence a regular suo-motu case under FIR No. 32 (12)2024 KJM PS U/S 281/125(b) /324(4)/106(1) BNS 2023 has been registered for investigation.
