With due respect and regard, I am to report that today i.e. 18/11/2024 at @ 2:30 pm an unruly mob numbering about 300/400 including female forcibly entered to my factory MS Priyobata Saw mill & MS Surjit Saw Mill located at Yairipok Khoirom Industrial Estate by holding iron rod, stick & stone and the following items were cause damaged by the unruly mob 1) JCB, 2) Peeling Machine – 9 Nos., 3) Crippler Machine – 6 Nos., 4) Dryer Machine – 4 Nos., 5) Wall Fencing & 6) Electric Motor – 10 Nos. 
